Appeal Procedures*

DLCD ACKNOWLEDGMENT or DEADLINE TO APPEAL: April 24, 2006

This amendment was submitted to DLCD for review prior to adoption with less than the required 45day notice. Pursuant to ORS 197.625 (1), 197.830 (2), and 197.830 (9) only persons who participated in the local government proceedings leading to adoption of the amendment are eligible to appeal this decision to the Land Use Board of Appeals (LUBA).

If you wish to appeal, you must file a notice of intent to appeal with the Land Use Board of Appeals (LUBA) no later than 21 days from the date the decision was mailed to you by the local government. If you have questions, check with the local government to determine the appeal deadline. Copies of the notice of intent to appeal must be served upon the local government and others who received written notice of the final decision from the local government. The notice of intent to appeal must be served and filed in the form and manner prescribed by LUBA, (OAR Chapter 661, Division 10). Please call LUBA at 503-373-1265, if you have questions about appeal procedures.

THE APPEAL DEADLINE IS BASED UPON THE DATE THE DECISION WAS ADOPTED BY LOCAL GOVERNMENT. A DECISION MAY HAVE BEEN MAILED TO YOU ON A DIFFERENT DATE THAN IT WAS MAILED TO DLCD.

CITY OF RAINIER ORDINANCE NO. <u>1028</u>

AN ORDINANCE TO AMEND THE CITY OF RAINIER COMPREHENSIVE PLAN MAP FROM MULTI-FAMILY RESIDENTIAL MFR TO COMMERCIAL

WHEREAS, applicants have requested to amend the City of Rainier Comprehensive Plan Map for Map T7 R2 Section 17 23 Tax Lot 100 (Lots 1-7) and Map T7 R2 Section 17 24 Tax Lot 2300 (Lots 15, 16 & 17) including approximately 1.37 acres from Multi-family Residential MFR to Commercial; and

WHEREAS, the City of Rainier Planning Commission did hold a duly noticed public hearing on February 28, 2006 and did conclude to recommend approval of such a change to the Rainier City Council; and

WHEREAS, the Rainier City Council did hold a duly noticed public hearing on March 20, 2006 and did find that after due consideration of all the evidence in the record compared to the criteria that they agreed with the application and the recommendation forwarded by the Rainier Planning Commission; and

WHEREAS, the City Council has considered findings of compliance with criteria and law applicable to the proposal;

NOW, THEREFORE, THE CITY OF RAINIER DOES ORDAIN AS FOLLOWS:

- 1. The above recitations are true and correct and are incorporated herein by this reference.
- 2. The City of Rainier Comprehensive Plan Map is amended to change the Plan designation of Multi-family Residential MFR to Commercial for land described as 1.37 acres including Tax Lot 100, Map T7 R2 Section 17 23 (Lots 1 7), and Tax Lot 2300 of Map T7 R2 Section 17 24 (Lots 15, 16, 17).
- 3. In support of the above amendment to the Comprehensive Plan Map, the City Council hereby adopts the Findings of Fact and Conclusions of Law in the City Staff Report dated February 21, 2006 for the Plan Map Amendment.
- 4. The effective date of this Ordinance shall be 30 days after approval, in accordance with the City Charter and other applicable laws.
