The Department of Land Conservation and Development (DLCD) received the attached notice of adoption. A copy of the adopted plan amendment is available for review at the DLCD office in Salem and the local government office.

Appeal Procedures*

DLCD ACKNOWLEDGMENT or DEADLINE TO APPEAL: June 5, 2007

This amendment was submitted to DLCD for review 45 days prior to adoption. Pursuant to ORS 197.830 (2)(b) only persons who participated in the local government proceedings leading to adoption of the amendment are eligible to appeal this decision to the Land Use Board of Appeals (LUBA).

If you wish to appeal, you must file a notice of intent to appeal with the Land Use Board of Appeals (LUBA) no later than 21 days from the date the decision was mailed to you by the local government. If you have questions, check with the local government to determine the appeal deadline. Copies of the notice of intent to appeal must be served upon the local government and others who received written notice of the final decision from the local government. The notice of intent to appeal must be served and filed in the form and manner prescribed by LUBA, (OAR Chapter 661, Division 10). Please call LUBA at 503-373-1265, if you have questions about appeal procedures.

***NOTE: THE APPEAL DEADLINE IS BASED UPON THE DATE THE DECISION WAS MAILED BY LOCAL GOVERNMENT. A DECISION MAY HAVE BEEN MAILED TO YOU ON A DIFFERENT DATE THAN IT WAS MAILED TO DLCD. AS A RESULT YOUR APPEAL DEADLINE MAY BE EARLIER THAN THE ABOVE DATE SPECIFIED.**

ORDINANCE NO. 3265

**AN ORDINANCE DECLARING A COMPREHENSIVE PLAN MAP AMENDMENT
CONCURRENT WITH A ZONE CHANGE OF 2.45 ACRES LOCATED EAST OF
KLINE STREET OWNED BY KLINE ST. COMMONS LIMITED PARTNERSHIP.**

WHEREAS, the Roseburg Urban Area Comprehensive Plan was adopted by the City Council in Ordinance No. 2345, effective on July 1, 1982, and re-adopted in Ordinance No. 2980 on December 9, 1996; and

WHEREAS, the Roseburg Land Use and Development Ordinance No. 2363, as originally adopted July 1, 1984, and re-adopted in Ordinance No. 2981 on December 9, 1996, establishes procedures for hearing Comprehensive Plan Amendment applications; and

WHEREAS, the Planning Commission received the application (File No. CPA-07-3/ZC-07-3) and held a Quasi-Judicial public hearing after due and timely notice; and

WHEREAS, the Planning Commission has adopted Findings of Fact supporting a recommendation to approve the applicant's request.

NOW, THEREFORE, THE CITY OF ROSEBURG ORDAINS AS FOLLOWS:

SECTION 1: The City Council hereby take official notice of the Planning Commission Findings of Fact and Decision dated April 2, 2007, recommending the request be granted without conditions and providing details supporting the approval as required by Section 6.150.2 and Section 3.38.100 including, but not limited to:

- a. The Amendment complies with the Statewide Planning Goals adopted by the Land Conservation and Development Commission, pursuant to ORS 197.240, or as revised pursuant to ORS 197.245;
- b. The Amendment complied with applicable policies of the Comprehensive Plan;
- c. There is a public need for a change of the kind in question;
- d. Such a need will be best served by changing the Plan designation of the particular piece of property in questions as compared with other available property;
- e. The rezoning will conform with the Roseburg Urban Area Comprehensive Plan, including the land use map and written policies; and,
- f. The site is suitable to the proposed zone with respect to public health, safety and welfare of the surrounding area.


SECTION 2: The City Council hereby amends the Roseburg Area Comprehensive Plan Map and Zoning Map for the following property:

2595 NW Kline St. and may be legally identified as a portion of Town 27 South, Range 06 West, Willamette Meridian, Section 11B, Tax Lot 101.

SECTION 3: The City Council hereby amends the Roseburg Area Comprehensive Plan Map by changing the designation from High Density Residential (HDR) to Professional Office (PO) as shown on Exhibit "A" attached hereto and made part of this ordinance concurrent with a Zone Change from High Density Residential (MR-29) to Professional Office (PO) for the subject parcel, as described above and as shown on the map labeled Exhibit "B" attached hereto and made part of this ordinance.

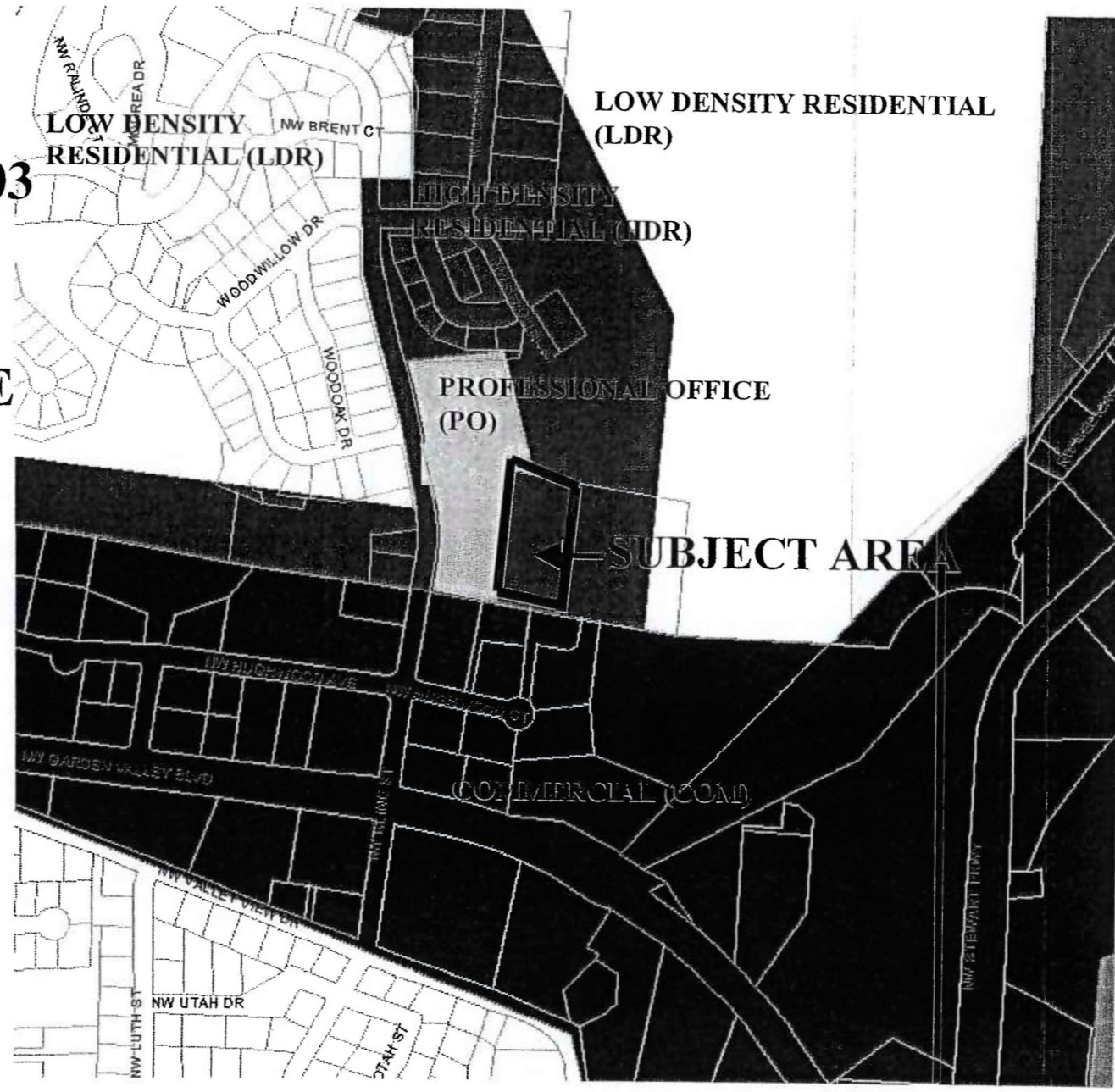
