Appeal Procedures*

DLCD ACKNOWLEDGMENT or DEADLINE TO APPEAL: October 16, 2008

This amendment was submitted to DLCD for review 45 days prior to adoption. Pursuant to ORS 197.830 (2)(b) only persons who participated in the local government proceedings leading to adoption of the amendment are eligible to appeal this decision to the Land Use Board of Appeals (LUBA).

If you wish to appeal, you must file a notice of intent to appeal with the Land Use Board of Appeals (LUBA) no later than 21 days from the date the decision was mailed to you by the local government. If you have questions, check with the local government to determine the appeal deadline. Copies of the notice of intent to appeal must be served upon the local government and others who received written notice of the final decision from the local government. The notice of intent to appeal must be served and filed in the form and manner prescribed by LUBA, (OAR Chapter 661, Division 10). Please call LUBA at 503-373-1265, if you have questions about appeal procedures.

*NOTE: THE APPEAL DEADLINE IS BASED UPON THE DATE THE DECISION WAS MAILED BY LOCAL GOVERNMENT. A DECISION MAY HAVE BEEN MAILED TO YOU ON A DIFFERENT DATE THAN IT WAS MAILED TO DLCD. AS A RESULT YOUR APPEAL DEADLINE MAY BE EARLIER THAN THE ABOVE DATE SPECIFIED.

The City of Cannon Beach does ordain as follows:

<u>Section 1.</u> Amend the Municipal Code, Section 17.71.060.B, Stream Corridor Protection, Standards, Transportation structures, to read as follows:

- B. Transportation structures, including roads, bridges, bridge crossing support structures and culverts, may be permitted subject to the following standards:
 - 1. Roads shall be constructed outside of the stream corridor except for required stream crossings.
 - 2. Streams shall be crossed only where there are no practicable alternatives.
 - 3. In order of preference, the priorities for stream crossing structures are:
 - a. Bridges; and
 - b. Bottomless culverts or other similar structures that have a demonstrated ability to provide for fish and wildlife passage.
 - 4. Proposals for stream crossings utilizing a bottomless culvert or other similar structure shall be reviewed by the Planning Commission, at a public hearing, pursuant to the requirements of Chapter 17.88. The Planning Commission shall approve such a stream crossing only where it finds that:
 - a. The site topography presents a material difficulty to bridge construction;

or

- b. Where it can be demonstrated that a bridge crossing would result in more damage to the stream and adjacent wetland and riparian area than a stream crossing utilizing a bottomless culvert or similar structure.
- 5. The stream crossing shall be designed so that the crossing does not diminish the flood-carrying capacity of the stream.
- 6. The stream crossing shall be no wider than necessary to serve its intended purpose.
- 7. Placement of the stream crossing structure shall minimize land clearing and site modification within the stream corridor. All debris, overburden and other construction materials shall be placed on nonwetland areas in a manner which prevents erosion into the stream.
- 8. Bridge crossing support structures shall not be located in the stream. Excavation for footings, piers and abutments shall be isolated from the wetted perimeter of the waterway by a dike, cofferdam or other structure.

- 9. Utility crossings shall be combined with stream crossings where feasible.
- 10. Where feasible, the number of stream crossings shall be minimized through the use of shared access for abutting lots.
- 11. Where adjacent upland consists of a wetland, applicable standards of Chapter 17.43 shall be complied with.

FINDINGS OF FACT

ZO 08-01, CITY OF CANNON BEACH, AMENDMENTS TO ZONING CODE, SECTION 17.71.060.B, STREAM CROSSING STANDARDS, TRANSPORTATION STRUCTURES

BACKGROUND

The City of Cannon Beach is proposing amendments to the transportation structures section of the stream corridor protection standards of Municipal Code, Section 17.71.060.B. The proposed amendments revise the standards to be considered when a design proposes to cross a stream corridor by means other than a bridge.

The Planning Commission held a public hearing on the proposed amendments on June 26, 2008.

The Council held a public hearing on the proposed amendments on August 5, 2008.

ANALYSIS/INFORMATION

CRITERIA - ZONING CODE

A. <u>Section 17.86.070 Criteria</u> provides that "before an amendment to the text of the ordinance codified in this title is approved, findings will be made that the following criteria are satisfied":

1. "The amendment is consistent with the comprehensive plan."

The following policies are applicable to the proposed amendments:

General Development Policy 14 states that it is the City's objective "to ensure that development is designed to preserve significant site features such as trees, streams and wetlands."

Recreation, Open Space, Natural, Visual and Historic Resources Policy 25 states that it is the City's objective "to protect, enhance and restore the functions and values of riparian corridors, which include water quality protection, storm and flood water conveyance, fish and wildlife habitat, and open space."

Finding: The proposed amendments would permit a stream crossing for access purposes by means other than a bridge where the site topography presents a material difficulty to bridge construction, or where it can be demonstrated that a bridge crossing would result in more damage to the stream and adjacent wetland and riparian area than a stream crossing utilizing a bottomless culvert or similar structure. Application of this standard will permit some additional design flexibility in stream crossings where site topography makes a bridge crossing impractical and where the use of a bottomless culvert or similar structure has less impact on the riparian area than a bridge. In those circumstances where a stream crossing by means other than a bridge is warranted, the use of a bottomless culvert will minimize the impact of the stream crossing on the functions and values associated with a stream corridor. Taken as a whole,



the proposed standards of Section 17.71.060.B will protect the identified functions and values of regulated stream corridors and by so doing implement the objectives of General Development Policy 14 and Recreation, Open Space, Natural, Visual and Historic Resources Policy 25.

<u>Conclusion:</u> The proposed amendment is consistent with General Development Policy 14 and Recreation, Open Space, Natural, Visual and Historic Resources Policy 25.

2. "The amendment will not adversely affect the ability of the city to satisfy land and water use needs."

<u>Finding:</u> The proposed amendments will have no impact on the ability of the City to satisfy land and water use needs.

Conclusion: This standard is met

CONCLUSION

The proposed amendments to the text of the zoning code meet the relevant criteria.

ACTION

The application is approved.
