DLCD ACKNOWLEDGMENT or DEADLINE TO APPEAL: Tuesday, November 16, 2010

This amendment was not submitted to DLCD for review prior to adoption pursuant to OAR 660-18-060, the Director or any person is eligible to appeal this action to LUBA under ORS 197.830 to 197.845.

If you wish to appeal, you must file a notice of intent to appeal with the Land Use Board of Appeals (LUBA) no later than 21 days from the date the decision was mailed to you by the local government. If you have questions, check with the local government to determine the appeal deadline. Copies of the notice of intent to appeal must be served upon the local government and others who received written notice of the final decision from the local government. The notice of intent to appeal must be served and filed in the form and manner prescribed by LUBA, (OAR Chapter 661, Division 10). Please call LUBA at 503-373-1265, if you have questions about appeal procedures.

- \*<u>NOTE:</u> The Acknowledgment or Appeal Deadline is based upon the date the decision was mailed by local government. A decision may have been mailed to you on a different date than it was mailed to DLCD. As a result, your appeal deadline may be earlier than the above date specified. <u>NO LUBA</u> Notification to the jurisdiction of an appeal by the deadline, this Plan Amendment is acknowledged.

# ORDINANCE 10-O-672, AN ORDINANCE AMENDING BROOKINGS MUNICIPAL CODE SECTION 17.144.020(J)(5), OF CHAPTER 17.144, ANNEXATIONS, TITLE 17, LAND DEVELOPMENT CODE.

Sections:

Section 1. Ordinance identified. Section 2. Amends Section 17.144.020(J)(5).

The City of Brookings ordains as follows:

Section 1. \_\_\_Ordinance Identified. This ordinance amends Brookings Municipal Code Section 17.144.020(J)(5), of Chapter 17.144, Annexations, Title 17, Land Development Code.

Section 2. Amends Section 17.144.020(J)(5). Section 17.144.020(J)(5) is amended to read as follows:

"17.144.020 (J). Written findings of fact prepared by the petitioner(s) or petitioner(s) representatives which address the following:

5. Urban services needed and necessary to service the territory proposed to be annexed, including the availability of the same relative to capacity, condition and cost of extension and/or improvement to urban standards and an estimated timeline for any required improvements. City staff will provide written information regarding existing infrastructure and any improvements that would be necessary to serve the territory proposed to be annexed, as well as any other properties within the urban growth area that would also be served by these improvements in the future."
