This amendment was submitted to DLCD for review prior to adoption pursuant to ORS 197.830(2)(b) only persons who participated in the local government proceedings leading to adoption of the amendment are eligible to appeal this decision to the Land Use Board of Appeals (LUBA).

If you wish to appeal, you must file a notice of intent to appeal with the Land Use Board of Appeals (LUBA) no later than 21 days from the date the decision was mailed to you by the local government. If you have questions, check with the local government to determine the appeal deadline. Copies of the notice of intent to appeal must be served upon the local government and others who received written notice of the final decision from the local government. The notice of intent to appeal must be served and filed in the form and manner prescribed by LUBA, (OAR Chapter 661, Division 10). Please call LUBA at 503-373-1265, if you have questions about appeal procedures.

*NOTE: The Acknowledgment or Appeal Deadline is based upon the date the decision was mailed by local government. A decision may have been mailed to you on a different date than it was mailed to DLCD. As a result, your appeal deadline may be earlier than the above date specified. NO LUBA Notification to the jurisdiction of an appeal by the deadline, this Plan Amendment is acknowledged.

**CITY OF PHILOMATH
ORDINANCE NO. 763**

AN ORDINANCE AMENDING THE PHILOMATH ZONING MAP TO CHANGE THE DESIGNATION OF INDUSTRIAL PARK TO HEAVY INDUSTRIAL FOR PROPERTY IN THE CITY OF PHILOMATH, AND MODIFYING ORDINANCE #720.

WHEREAS, the owner of those certain properties within the City of Philomath have proposed to change the zoning from Industrial Park to Heavy Industrial; and

WHEREAS, Ordinance #720 adopted and approved the Philomath Comprehensive Plan Map and the Philomath Zoning Map; and

WHEREAS, the Planning Commission of the City of Philomath held a duly noticed public hearing and recommended that the City Council approve the proposed zone change; and

WHEREAS, the City Council of the City of Philomath held a duly noticed public hearing on the proposed zone change; and

WHEREAS, following the public hearing, the City Council deliberated and found that the proposed change met the required criteria and approved the proposed changes; now therefore:

THE CITY OF PHILOMATH ORDAINS AS FOLLOWS:

Section 1: The City of Philomath Zoning Map, adopted through Ordinance #720, as amended, shall be amended so that the properties described and shown in "Exhibit A" attached, in the City of Philomath, currently zoned "Industrial Park" will be zoned as "Heavy Industrial".

Section 2: The Planning Official shall make such changes to the City of Philomath Comprehensive Plan Map and the City of Philomath Zoning Map as are required to implement this amending ordinance.

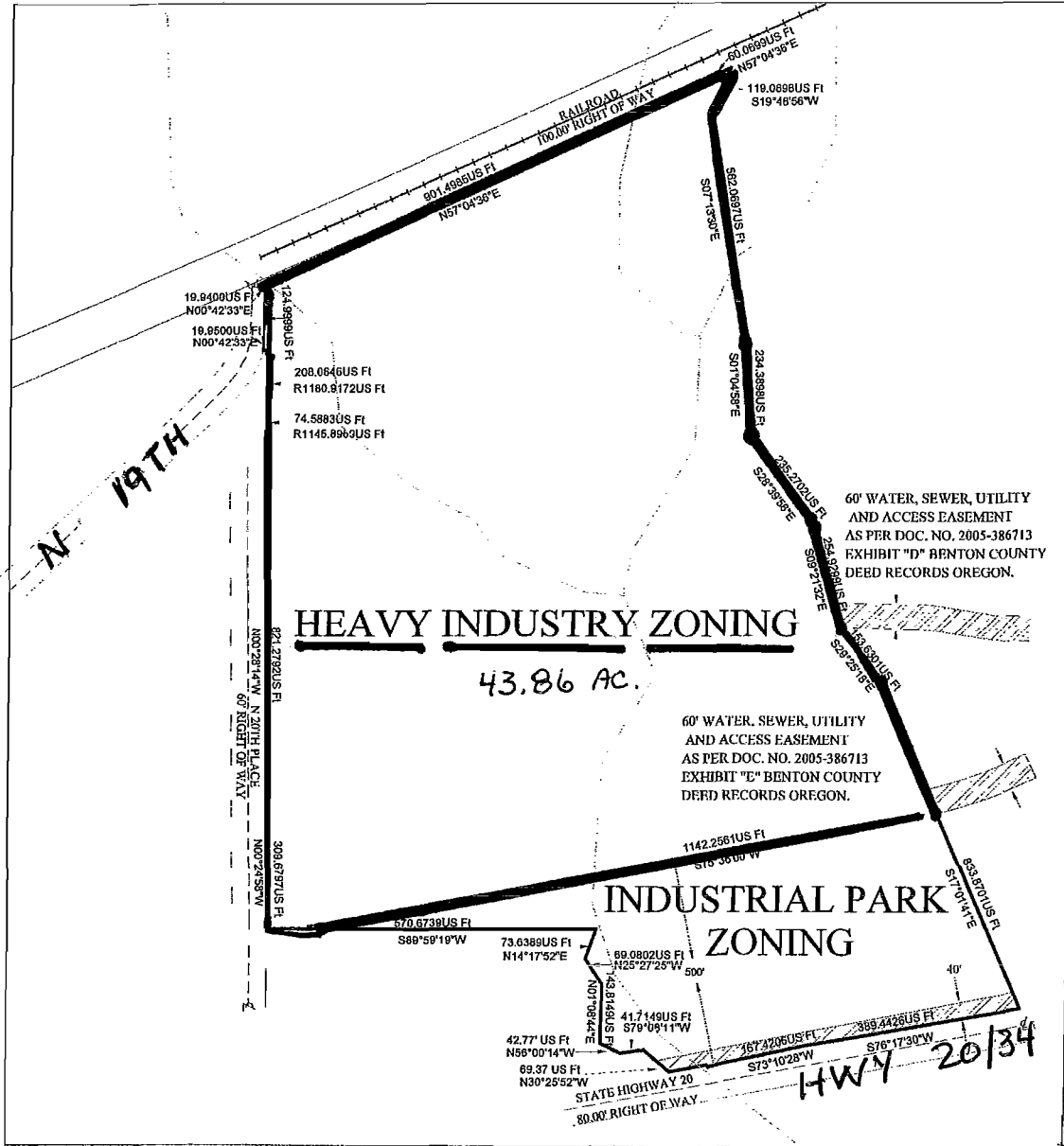
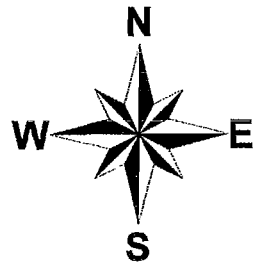

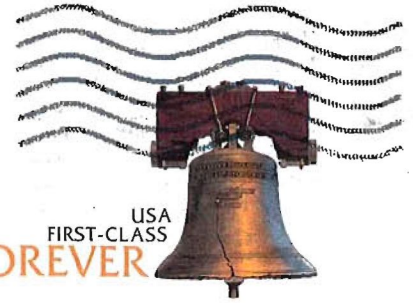
