Appeal Procedures*

DLCD ACKNOWLEDGMENT or DEADLINE TO APPEAL: Monday, June 27, 2011

This amendment was submitted to DLCD for review prior to adoption with less than the required 45-day notice. Pursuant to ORS 197.830(2)(b) only persons who participated in the local government proceedings leading to adoption of the amendment are eligible to appeal this decision to the Land Use Board of Appeals (LUBA).

If you wish to appeal, you must file a notice of intent to appeal with the Land Use Board of Appeals (LUBA) no later than 21 days from the date the decision was mailed to you by the local government. If you have questions, check with the local government to determine the appeal deadline. Copies of the notice of intent to appeal must be served upon the local government and others who received written notice of the final decision from the local government. The notice of intent to appeal must be served and filed in the form and manner prescribed by LUBA, (OAR Chapter 661, Division 10). Please call LUBA at 503-373-1265, if you have questions about appeal procedures.

*NOTE: The Acknowledgment or Appeal Deadline is based upon the date the decision was mailed by local government. A decision may have been mailed to you on a different date than it was mailed to

DLCD. As a result, your appeal deadline may be earlier than the above date specified. <u>NO LUBA Notification to the jurisdiction of an appeal by the deadline, this Plan Amendment is acknowledged.</u>

ORDINANCE (2-2011)

AN ORDINANCE OF THE CITY COUNCIL OF THE CITY OF FAIRVIEW, FAIRVIEW, OREGON, AMENDING FAIRVIEW MUNICIPAL CODE CHAPTER 19.170 SIGN REGULATIONS FOR ELECTRONIC MESSAGE CENTERS, PENNANTS, AND OTHER MINOR CHANGES.

WHEREAS, public hearings were held by the Planning Commission on January 25, 2011 and April 26, 2011 and by the City Council on June 1, 2011 and

WHEREAS, notice of said hearings was provided in accordance with Fairview Municipal Code 19.416 and Oregon Revised Statutes 227.186, and

WHEREAS, amendments are consistent with the Fairview Municipal Code and comprehensive plan policies and provisions, and

WHEREAS, Chapter 19.170 Sign Regulations was adopted in 1990 under Ordinance 9-1990, and

WHEREAS, the amendments adopted under this ordinance address follow-up items to Ordinance 2-2010, adopted in July 2010, to improve the City of Fairview's sign regulations by:

- a. Developing standards for displays on electronic message centers,
- b. Improving standards for the time, place and manner for the use of pennants,
- c. Regulating the number of projecting signs and awning signs allowed in the Village Mixed Use zone based on business frontage and,
- d. Creating definitions of scroll, site, and flashing to more easily apply sign regulations.

WHEREAS, the purpose of this ordinance is to create sign regulations that meet the needs of businesses and residents while also protecting pubic safety and preserving the aesthetic character of the community.

NOW, THEREFORE; The City of Fairview ordains as follows:

Section 1. FMC Chapter 19.170 is amended as shown in Attachment 1.

Section 2. This ordinance shall be effective upon and from 30 days of adoption.

Proposed Code Amendments to Fairview Municipal Code (FMC) Section 19.170 Sign Regulations

Strike through-indicates language to be deleted. <u>Underline</u> indicates proposed language.

FMC 19.170.020 Definitions

"Scroll" means the continuous movement of a message on an electronic message center in a horizontal, vertical or diagonal direction.

"Site" means the area, tract, parcel or lot of land.

"Flashing" means an intermittent or sequential light source used primarily to attract attention.

19.170.080 Exemptions

B. Signs exempt from permitting requirements in 19.170.030.

The following signs shall not require a permit but shall conform to all other applicable provisions of this title:

13. Pennants.

a. May not obstruct sidewalks or driveways.

b. May not be placed in the right of way.

c. Pole on which pennant is attached may not exceed 15 feet in height.

d. Area of pennant may not exceed 24 square feet.

e. One (1) pennant allowed per 100 feet of site frontage with a maximum of six (6) pennants per frontage.

f. Pennant and structure to which pennant is attached must be properly secured to prevent property damage or personal injury due to movement by wind or other physical force. g. Pennants must be properly maintained; any torn or tattered pennants must be removed or replaced immediately.

h. Prohibited in single family residential zones (R, R-7.5, R-10, R/SFLD, VSF, VTH).

FMC 19.170.120 Permitted signs within Community Service Parks (CSP) Zone

1. Sign Features.

c. Electronic Message Center. An electronic message center may be incorporated into either a freestanding sign or wall sign, but not both. The electronic message center shall be an integral part of the sign design and shall not exceed eight (8) square feet.

The display of messages shall conform to the following standards:

Deleted: Flashing signs are prohibited. Not permitted in the single family residential zone.

FMC 19.170.130 Permitted signs within Commercial and Light Industrial zones (CC, TCC, NC, LI, VO, and VC)

B. Sign Features.

3. Electronic Message Center. An electronic message center may be incorporated into either a freestanding sign or wall sign, but not both. The electronic message center shall be an integral part of the sign design and shall not exceed eight square feet.

Deleted: Flashing signs are prohibited.

The display of messages shall conform to the following standards:

i. Messages may scroll across the electronic message center.

ii. Flashing messages are prohibited.

19.170.140 Permitted signs within Village Mixed Use (VMU) Zone. All permanent signs are subject to permitting requirements in FMC 19.170.030.

A. Ground story and upper story signs may only be placed on the front elevation except for mixed use townhouses that have ground story doors or windows along driveways, walkways, or parking areas. In such cases window signs up to 25% of the total window area are allowed.
