DLCD ACKNOWLEDGMENT or DEADLINE TO APPEAL: Friday, June 29, 2012

This amendment was submitted to DLCD for review prior to adoption pursuant to ORS 197.830(2)(b) only persons who participated in the local government proceedings leading to adoption of the amendment are eligible to appeal this decision to the Land Use Board of Appeals (LUBA).

If you wish to appeal, you must file a notice of intent to appeal with the Land Use Board of Appeals (LUBA) no later than 21 days from the date the decision was mailed to you by the local government. If you have questions, check with the local government to determine the appeal deadline. Copies of the notice of intent to appeal must be served upon the local government and others who received written notice of the final decision from the local government. The notice of intent to appeal must be served and filed in the form and manner prescribed by LUBA, (OAR Chapter 661, Division 10). Please call LUBA at 503-373-1265, if you have questions about appeal procedures.

*NOTE: The Acknowledgment or Appeal Deadline is based upon the date the decision was mailed by local government. A decision may have been mailed to you on a different date than it was mailed to DLCD. As a result, your appeal deadline may be earlier than the above date specified. NO LUBA

ORDINANCE NO. 654

AN ORDINANCE ADOPTING AMENDMENTS TO THE CITY OF WINSTON ZONING ORDINANCE AND CITY OF WINSTON SUBDIVISION ORDINANCE

Whereas, the City of Winston Planning Commission held ten workshops between April 14, 2010 and October 26, 2011, and whereas a public hearing was held on March 7, 2012, and whereas the Winston City Council held a workshop on March 23, 2012, and whereas one public hearing was held on April 2, 2012 before the City Council to consider the following proposed legislative amendments:

- Legislative amendments to the Zoning Ordinance include: change "City Administrator" to "City Manager"; update definitions of Building & Structure; add definition of Condominium & add use to RM & RH zones; clarify number of dwelling units permitted in RH zone; add Day Care facilities as permitted uses to CG & COP zones; clarify height of fences & walls; clarify parking area & driveway design standards; add SHPO to notice for land use actions; update floodplain standards with applicable FEMA & state building code provisions, including requirements for manufactured homes; clarify Section 11.300 for appeals of City Manager Decisions; add beekeeping in residential zones & add approval standards for such use; and modify Article 13 (Repeal) and repeal Article 15 (Nuisances & Abatement), which is being made into a separate City ordinance.
- Legislative amendments to the Subdivision Ordinance include: change "City Administrator" to "City Manager"; and add footnotes to Table D and Illustrations 1-5 in Section 11.C and modify Section 11.O to clarify sidewalk standards in residential zones.

Whereas, Amendments to the City of Winston Zoning Ordinance and Subdivision Ordinance are needed to clarify regulations, streamline, deregulate and/or improve these ordinances for the City of Winston.

Whereas, on March 7, 2012, the Planning Commission held a public hearing and recommended that the amendments be adopted by the City Council.

NOW THEREFORE, THE CITY OF WINSTON ORDAINS AS FOLLOWS:

SECTION ONE: FINDINGS OF FACT

- A. The Winston Planning Commission conducted ten workshops on the proposed legislative amendments to the Zoning Ordinance and Subdivision Ordinance between April 14, 2010 and October 26, 2011.
- B. A public hearing on the proposed legislative amendments to the Zoning Ordinance text and Subdivision Ordinance text was held before the Planning Commission on March 7, 2012. Opportunity was provided for public participation during the hearing and the Planning Commission was provided written comment and oral testimony for consideration.

- C. The Planning Commission forwarded a recommendation to City Council to adopt the proposed legislative amendments, which included minor revisions suggested by the Superintendent of Public Works.
- D. A City Council conducted a workshop on the proposed legislative amendments on March 23, 2012.
- E. The City Council accepted the recommendation of the Planning Commission and did not make any additional revisions to the proposed amendments.
- F. A public hearing on the proposed legislative amendments to the Zoning Ordinance text and Subdivision Ordinance text was held before the City Council on April 2, 2012. Opportunity was provided for public participation during the hearing. No members of the public were present to provide written comment or oral testimony to City Council.

SECTION TWO: AMENDING ZONING ORDINANCE TEXT AND SUBDIVISION ORDINANCE TEXT.

The amendments to the Winston Zoning Ordinance Text, and Winston Subdivision Ordinance Text are hereby attached to this ordinance and identified as Exhibit A, Adoption Draft dated April 16, 2012, and by this reference made part of this ordinance. This adoption draft has the same contents as the Second Draft, dated April 2, 2012, presented at the City Council hearing, except for the updated cover sheet to acknowledge adoption.

SECTION THREE: EFFECT OF AMENDMENT

Ordinance Nos. 590 (Winston Zoning Ordinance) and 591 (Winston Subdivision Ordinance) heretofore and herein amended; remain in full force and effect.

First reading before the City Council on the 16th day of April, 2012.
