The notice of intent to appeal must be served and filed in the form and manner prescribed by LUBA, (OAR Chapter 661, Division 10). 
WHEREAS, the Board of County Commissioners ("Board") conducted a public hearing on January 5, 2009 and approved the zone change; now therefore,
